Implicit terror threat against CJEU judges from corrupt Brussels officials

Von der Leyen - Belgium corruption agreement to violate CJEU Court Orders

Criminal threat of murder of witness and litigant proceeding to CJEU

EPPO Chief Prosecutor Kövesi paralysed and intimidated by Brussels criminals

Dear President Lenaerts,

With this note I write to you as someone who may soon be murdered by criminals associated with Belgian government and Ursula von der Leyen, who openly collude to brutally violate orders of the CJEU and EU Citizen rights ... and who may be desperate enough to do physical terrorist harm to yourself or other CJEU judges and officials, as part of their intimidation.

As I may be dead before I can make my CJEU court filing, I wish you to be aware of this situation, how Von der Leyen spits in the face of the CJEU and violates your most important Court Orders in bribery games, whilst intimidating all other EU Institutions such as EPPO.

To be brief, Ursula Von der Leyen seems to be in major financial crimes involving millions, with her husband in the covid vaccine business. You know Belgium has jurisdiction over crimes in EU offices, so OLAF and EPPO would need to use Belgian officials to prosecute.

Von der Leyen shields herself by engaging in open corruption with Belgian gov't ministers, particularly notorious Belgium Health Minister Frank Vandenbroucke, previously involved in bribery and linked to a political murder ... and linked to Von der Leyen's husband in covid vaccines. Vandenbroucke is said to have friends who can kill judges such as yourself.

With full participation of Von der Leyen and corrupt EU Justice Commissioner Didier Reynders, Belgium operates a bribery-extortion scheme over EU Citizen Rights, openly violating your historic, important CJEU historic Court Order C-535/19 of 15 July 2021, guaranteeing universal EU Citizen national Health System Access as part of EU Treaty Freedom of Movement, when no other EU Health system is covering the citizen.

Living in Belgium, I am a Polish citizen who became a victim of this bribery-extortion scheme, racist Belgians thinking I was a 'rich Jew with secret Jew money' so I should pay a bribe to join Belgium's health system. I fought the corruption in both Belgium and at the EU Commission, and now I live in fear of my life. Belgians tell me I may be dead soon, whilst I also am subject to a form of attempted murder by illegal denial of health system access if I get sick.

The Belgium system of demanding bribes from EU citizens as they violate CJEU Court Orders - Belgian officials so shameless they even request bribes by e-mail - is fuelled both by the sponsoring corruption of Von der Leyen and Reynders in EU Commission offices, and by ultraslow Belgian courts which can take 4 to 20 years to process a legal case. And the Belgian Health Ministry, misusing EU Covid-19 funds with EU Commission approval, hires racist

psychopath lawyers to delay obeying CJEU orders, the lawyers' contracts then becoming an alternative source of kickback-bribery funds for bribe-seeking officials under Vandenbroucke.

In this photo you see a dead man, this murder often linked to the Agusta-Dassault bribery scandal ... the 1990s scandal involving the very same Frank Vandenbroucke who today runs bribery-extortion operations violating EU Court Order C-535/19 ... this murder serves today as ongoing terror for anyone who speaks against the corruption of Belgium government:



Belgian and EU officials do their utmost to avoid discussing CJEU Court Order C-535/19, as your very clear, simple, unambiguous Court Order proves them all to be criminals. The Belgian bribe seekers try to hide the Court Order, and refuse to answer questions about it. They denied my health care rights for the exact reason CJEU Court Order C-535/19 declared to be entirely illegal, that I am 'economically inactive' as a pensioner. When extremely pressed, the laughing bribe-seeking Belgians finally wrote me that your CJEU Court Order is 'doubtful and uncertain' and must be 'studied' for likely many years into the future before anyone can understand it. When of course no one is 'studying' anything about clear law. Belgian police are under strict orders to not prosecute crimes against me by this gang.

At the EU Commission, honest EU Commission staffers are being intimidated and terrorised by Von der Leyen, who has ordered that for a victim like myself showing proof of Belgian violations of EU Law, my dossier is only to be handled by Belgian EU 'Justice' Commissioner Reynders for his Belgian government friends, Reynders' assistant being Von der Leyen's racist 'German sister' Monika Mosshammer. They handled my dossier by delaying a reply for 9 months, then spitting lies into my face about never receiving information, and then just declared nothing would be done for me ... with no discussion of your CJEU Court Order C-535/19 nor the written proof Belgium is violating it, just their pleasure in breaking EU law.

Maybe more shocking, is that after this misconduct by Reynders and Von der Leyen, I received similar stupid lies from the EU Ombudsman, the EU Ethics Secretariat and even Ville Itälä at OLAF, all of them refusing to discuss CJEU Court Order C-535/19, the proof of Belgium violating this order, the proof of EU Commission lying, demands for bribes, etc. In an EU total corruption circle, all wrote stupid lies about 'no violations of EU law, no misconduct, no conflict of interest in Reynders handling dossiers for his fellow party group members running Belgian government'. Laura Kövesi at EPPO is the only one holding back, she knows about all the crimes, but seems paralysed and terrified and says nothing. She seems to know that prosecuting Von der Leyen can result in her being dead.

Another aspect of this Von der Leyen - EU Commission - Reynders - Belgium gov't corruption network, is that the threats to CJEU judges and officials, may come from an even deeper source than the criminal friends of Von der Leyen and Belgium's gangster Health Minister, and the wish of the Von der Leyen family to not be prosecuted for possible huge crimes involving millions flowing now in the near future to Heiko von der Leyen's vaccine business.

Von der Leyen, corrupt to the core regarding both the covid vaccine contracts and her joining in bribery-extortion crimes with Belgium and violation of CJEU Court Orders, is thought by some at the EU to be under blackmail by foreign powers, and this is related to Von der Leyen's continuous posturing and promotion of military conflict in Ukraine. For Von der Leyen, the now hundred-thousand-plus dead in Ukraine, are not only an excellent distraction from her personal corruption ... she may also be 'under orders' via international blackmail, to promote the war and armaments sales etc., or else suffer greater exposure of her crimes by media which can be harnessed by blackmailers.

Billions of profit are involved in the war machine, and people involved in that may be willing to kill to protect that money - kill me as a witness, or murder CJEU judges who might dare to not be submissive to the fraud and hypocrisy of Ursula von der Leyen, Didier Reynders, and 'Rule of Law' EU Commissioner Věra Jourová, who has decided it is better for her career to go along with this murderous corruption and contemptuous violation of CJEU Court Order.
